__ I have read, understand, and will comply with the AMA and GSLMA safety rules that are posted at Buder Park. These rules are enforced by St. Louis County Ordinance 616.180

__ AMA Full "OPEN" Membership required for full liability coverage, per St. Louis County Parks. "Park Flyer" permits are not allowed at Buder Park.

__ I will NOT fly my aircraft in the NO-FLY zones. I have reviewed the map at the flying field showing the NO-FLY zones and understand the location of these zones.

__ I will comply with the instructions of all GSLMA safety officers, club representatives or other permit holder who detects a safety violation, whether intentional or not. I will show my GSLMA current card to any other card member when asked.

__ I understand that failure to comply with any of the safety rules safety codes and rules of conduct, can result in disciplinary action, up to and including loss of flying privileges at Buder Park.

__ Only radios with Narrow Band Aircraft frequencies 27Mhz, 50Mhz, 72Mhz and 2.4Ghz are allowed.

__ Radio control vehicles and other equipment utilizing the 75Mhz Band Frequencies are NOT permitted at Buder Park.

__ A First-Aid Kit is located at each flying pavilion. The combination to the lock is on the permit.

__ Buder Park Flying Permits are effective each year from January 1st to December 31st and Expire the following year.

__ Permit fee is \$30.00 per year. It is required by law to have a permit to use Aircraft and Control Line and Drone areas.

Penalty for using these areas without a permit can be up to \$1,000 dollars and or 1 year in jail, enforced by St Louis County Park Rangers. A Junior Permit 16 years and younger is \$1.00 per year.
